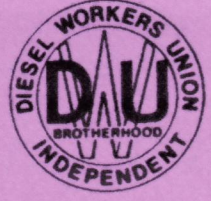

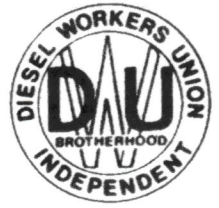

AUGUST 26th, 2024

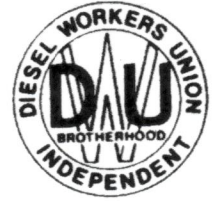

ON MONDAY, AUGUST 26th, 2024 AND SIGNING A DECLARATION OF INTENT. SUCH UNION MEMBERS MAY CONTINUE TO FILE DECLARATION OF INTENT DURING THE HOURS OF 7:00A.M. TO 7:00P.M. WEEKDAYS UNTIL THE DECLARATION DEADLINE, WHICH IS FRIDAY, AUGUST 30th, 2024.

2024 ELECTION COMMITTEE TO BE ELECTED AT UNION MEETINGS
OF AUGUST 27th & 28th, 2024

UNION MEMBERS WHO HAVE A DESIRE TO SERVE ON THE 2024 ELECTION COMMITTEE SHOULD ATTEND THE MONTHLY MEMBERSHIP MEETING OF THEIR SHIFT AND LOCATION TO BE HELD AUGUST 27th AND AUGUST 28th, 2024. **FOR COLUMBUS LOCATIONS, TWO (2) COMMITTEEMEN WILL BE ELECTED FROM THIRD SHIFT, TWO (2) COMMITTEEMEN WILL BE ELECTED FROM SECOND SHIFT AND FIVE (5) COMMITTEEMEN FROM THE FIRST SHIFT. FOR SEYMOUR LOCATION, ONE (1) COMMITTEEMEN WILL BE ELECTED FROM SECOND SHIFT, THREE (3) COMMITTEEMEN WILL BE ELECTED FROM FIRST SHIFT. FOR CMEP LOCATION, TWO (2) COMMITTEEMEN FROM THIRD SHIFT, ONE (1) COMMITTEEMEN FROM SECOND SHIFT AND FOUR (4) COMMITTEEMEN WILL BE ELECTED FROM FIRST SHIFT.**

IN ORDER TO SERVE, YOU MUST HAVE YOUR NAME PLACED IN NOMINATION SECONDED AND THOSE MEMBERS IN ATTENDANCE WILL TAKE A VOTE. THE CANDIDATES WHOSE NAMES HAVE BEEN PROPERLY PLACED IN NOMINATION AND WHO RECEIVE THE HIGHEST NUMBER OF VOTES WILL BE ELECTED TO SERVE UNTIL THE QUOTA FOR EACH MEETING SESSION IS FILLED. IF THERE ARE OTHERS, THEY WILL BE PUT ON A LIST OF ALTERNATES IF NEEDED. THERE WILL BE A TOTAL OF TWENTY (20) COMMITTEEMEN ELECTED AND THESE TWENTY (20) WILL CONSTITUTE THE ELECTION COMMITTEE. MAIL BALLOTING WILL BE USED.

YOU ARE REMINDED THAT TO SERVE ON THE ELECTION COMMITTEE IS A VERY SERIOUS RESPONSIBILITY. IF YOU WISH TO SERVE, PLEASE TAKE THIS RESPONSIBILITY VERY SERIOUSLY.

OFFICES TO BE FILLED FOR (3) THREE YEARS TERM WILL BE:

PRESIDENT
(2) BOARD MEMBERS
(1) TRUSTEE

THE FIRST DAY FOR CANDIDATES TO SIGN UP WILL BE MONDAY, AUGUST 26th, 2024, AND EACH WORKING DAY UNTIL FRIDAY, AUGUST 30th, 2024. SIGN UP WILL BE FROM 7:00A.M. UNTIL 7:00P.M. WEEKDAYS AT THE UNION BUSINESS OFFICE.

THE ELECTION COMMITTEE WILL BE ELECTED AT THE MONTHLY MEMBERSHIP MEETINGS ON AUGUST 27th AND 28th. IF YOU WOULD LIKE TO SERVE ON THE ELECTION COMMITTEE, PLAN TO BE IN ATTENDANCE AT ONE OF THE AUGUST MONTHLY MEETINGS.

TO ALL DWU MEMBERS

UNION BY-LAWS ARTICLE VI SECTION FIVE:

No members shall be eligible to file his/her declaration as a candidate for an office of this Union unless he/she has been a member in good standing in said Union for at least two (2) consecutive years.

Intent of this paragraph: As long as a member has paid Union Dues for two (2) consecutive years during any time period and still has recall rights and was back to work they would be allowed to run for an office of the Union.

If a member of the Union was laid off and lost their recall right and then was rehired he/she could run for office two (2) years after his/her rehire date.

A. Section 504 of the LMRDA prohibits persons convicted of certain crimes from holding union office for a maximum of 13 years following conviction or the end of imprisonment (whichever is later).
